## 2011 CONDITIONS OF ENTRY – ANL Maritime Art Prize & Exhibition

- 1. The Prize** - The ANL Maritime Art Prize is a National competition hosted at the Mission to Seafarers Victoria, Docklands. The Exhibition runs from 6 October until 23 October 2011. Artists are invited to submit work(s) for the acquisitive 'ANL Maritime Art Prize', valued at \$15,000, the "Best in Traditional Maritime Art Award" acquisitive Prize, valued at \$5,000, Bendigo Wealth Emerging Artist Award \$5,000 and the World Trade Centre People's Choice Award valued at \$2,000.
- 2. Closing date** for entries is Monday 5<sup>th</sup> September 2011. Send your form to Mission to Seafarers Victoria, 717 Flinders Street, Docklands VIC 2008
- 3. Entry fee** is \$33.00 (inc. GST) for each proposal. Entry fees are non-refundable. Payment may be made by Cheque or Money Order payable to The Mission to Seafarers Victoria or with Credit Card details on the entry form.
- 4. Curator** for the 2011 ANL Maritime Art Prize and Exhibition is Claire Ulenberg (MA Art Curatorship, University of Melbourne)
- 5. Works eligible.** Proposed work(s) – traditional or contemporary, with a maritime theme, must be either painting/image-making utilising any medium, but specifically excluding photographic or computer generated images, prints, ceramics or sculptures.
- 6.** Artists are invited to submit up to two (2) works both are eligible for selection. Selected works are accepted into the exhibition on the following terms: a) The work is an original work of the artist; b) The work has been produced within the past 2 years and not previously exhibited in the ANL Art Prize; c) Overall dimensions, including frame, do not exceed 140 cm x 140 cm (this applies to the total work as defined in (d)); d) Multiple panel proposals must be accompanied by a clear image of the assembled work and hanging instructions; e) The work must be completely dry when delivered (The Mission to Seafarers Victoria and/or The Art Prize Committee accepts no responsibility for any damage caused by the work not being completely dry); f) The work is for sale and a 33% commission will be deducted from the sale price; g) Commission will also apply to the sale of any works exhibited in this Exhibition within two (2) months of the last day of the Exhibition; h) Artist payments will be made within 30 days following full payment by the purchaser. Funds raised go to support the not-for-profit work of the Mission to Seafarers – thank you.
- 7. The signed Declaration and completed Entry Form** is to be returned to "The Art Prize, The Mission to Seafarers Victoria, 717 Flinders Street, Docklands Victoria 3008 together with the following: a) Full details and information of the work(s) submitted; b) A hi res image (preferably in JPEG format) and a photograph of the work(s); c) A brief description of the proposed work(s); d) A brief artist's statement (max. 25 words); e) A brief artist's biography (max. 25 words) and an up to date CV; f) Applicable entry fees; g) The selling price and h) The nominated address and return carrier information.
- 8. Selected artists will be notified** by mail by Monday 12 September and invited to present and deliver their work to 'The Art Prize', The Mission to Seafarers Victoria, 717 Flinders Street, Docklands, Victoria 3008 (Melway Ref 43:E10) on Friday 23 or Saturday 24 September. In 2011 we anticipate providing the opportunity for Selected Artists, who are interested, to feature additional works to be sold via a web based gallery during the exhibition dates.

The selection for hanging and the judges' decision will be final and no discussion or correspondence will be entered into.

- 9. Judging** for the ANL Art Prize will take place on Friday 30<sup>th</sup> September and the **winners will be announced at the Official Opening** to be held at 6.30pm on Thursday 6<sup>th</sup> October 2011. The winner of the People's Choice Award will be announced at the conclusion of the Exhibition. Artists will be invited to attend the Opening, the winner will be notified Friday 30<sup>th</sup> September.

Nadine Christensen - MA, (Research) candidate at Monash University. Melbourne based contemporary Artist .
- 10. Open days to the Public** will be from Friday 7 October – Sunday 23 October 2011, Wednesday to Sunday 12noon to 7pm.

Artists exhibit at their own risk and will be responsible for the cost of freight each way and insurances whilst in transit and exhibition. It is the responsibility of the artist to ensure works are professionally and securely packaged for transport/delivery and have glass taped and corners protected. Works framed under perspex should be clearly marked for cleaning purposes. Neither the Mission to Seafarers, the Art Prize Committee nor the sponsors of the Exhibition will be responsible for any loss or damage, however caused, to any work while in their custody.

- 11.** Works must be well presented, well labelled on the back, ready to be hung with secure hooks and hanging wires.
- 12.** The Art Prize Committee reserves the right to reject any wet, dangerous or delicate works that cannot be safely exhibited, or any work received in unsuitable exhibition condition.
- 13.** The Art Prize Committee reserves the right to reproduce any works for promotional purposes.
- 14. Collection** of all unsold works at the conclusion of the Exhibition is the responsibility of the artist. Works are to be collected between 10am and 4pm on either Wednesday 26, Thursday 27, Friday 28 October between 4pm and 7pm. An artist's signed authority is required if an agent of the artist is collecting.

Other works will be dispatched 'Pay on Delivery/Freight Collect to the nominated return address and carrier listed on the entry form.

If works are not collected within 3 months of collection date, work will be treated at the discretion of The Art Prize Committee and/or the Management of The Mission to Seafarers Victoria Inc.
